# 1 Introduction

## 1.1 General

EPSG DS 310 specifies the mandatory test cases for certification of POWERLINK CNs.

A major number of these test cases is being covered by the conformance test software "openCONFORMANCE". The latest version of this program valid for certification is always available for download on the POWERLINK portal of the B&R website.

The remaining test cases are being conducted using a B&R X20 CPU as POWERLINK MN and B&R Automation Studio.

This document specifies the technical procedure of a POWERLINK Certification, covering the usage of openCONFORMANCE and the execution of test cases using the B&R X20 POWERLINK MN.

A device passing all test cases of openCONFORMANCE, as well as all test cases being conducted with the B&R X20 CPU as POWERLINK MN, passes the POWERLINK certification.

## **1.2 Different device types**

For some tests, test execution is depending on the DUT's device type and is therefore differing from the approach of standard POWERLINK CNs. For this reason, this document contains related information on requirements and additional or differing test procedures for modular POWERLINK devices and openSAFETY over POWERLINK devices.

The following sub sections provide further information on the device types and the denotation of related information throughout the document.

An overwiew of differences in test execution for affected tests is given in table Tab. 3, p. 28.

### 1.2.1 Information for modular devices

When testing a modular device, related denoted information has to be considered:

Information referring to modular POWERLINK devices is denoted with this dedicated border style.

## 1.2.2 Information for openSAFETY devices

When testing an openSAFETY over POWERLINK device, related denoted information has to be considered:

Information referring to openSAFETY devices is denoted with this dedicated border style.

For testing openSAFETY over POWERLINK devices, general kow-how regarding commissioning and operating safety devices with the B&R system is required. If tests require a B&R SafeLOGIC, make sure that each device is used in the SafeDESIGNER program.

#### 2 openCONFORMANCE

#### **Requirements** 2.1

#### Hardware 2.1.1

#### 2.1.2 Software

- Windows 10(x32/x64) 0
- openCONFORMANCE. The latest valid version relevant for certification is available on the 0 POWERLINK portal of the B&R website (all-in-one ZIP package).

#### 2.2 Test setup

Connect the Ethernet interface of the PC and the DUT to the hub using standard CAT5 cables.

#### 2.3 Test execution

- 1. Prior to executing openCONFORMANCE, remove the TCP/IP protocol binding from the network interface that will be used by openCONFORMANCE. Close all other programs and run openCONFORMANCE.exe in the main directory or using the shortcut in the start menu as user "Administrator".
- 2. Import the XDD file using the menu "File Import XDD file".
- Set your network-interface and the POWERLINK-Cycletime under "Edit" -> "Preferrences".
   Upon successfully importing the XDD, select (checkbox), execute ("Run Test") and generate a test report ("File" -> "Generate test report")for each of the following testgroups/test cases separately:
  - a. Bootup-Tests
  - b. SDO-Tests
  - c. NMT-State Tests
  - d. OD-Tests excluding Testcase\_3\_2\_9\_T1
  - e. Testcase\_3\_2\_9\_T1
  - f. Error-Behavior
  - g. Extension-Compatibility
- 5. This will result in 7 test reports being generated, each being opened when the generation is done.
- 6. A DUT has successfully passed the openCONFORMANCE tests, if all test reports contain an "Overall Testresult: PASSED" under the "Test-Statistics" section.

- SafeDESIGNER 4.3.3.7 or higher
- o Automation Runtime B4.44 or higher
- Wireshark 2.0 or higher + Ethernet Analyzer Plugin for B&R X20ET8819

## 3.2 Test setup

The test setup may vary depending on the test case being conducted (most test cases do not require a second B&R X20 CPU to be present as iCN).

Basic setup: Connect one PC Ethernet interface to the standard Ethernet interface of the B&R X20 CPU (for Automation Studio project transfer), connect the second one to the hub (to enable network traces during test execution). In order to avoid distortions by the tracing PC, disable all network protocols on the PC's second Ethernet interface.

Connect the POWERLINK interfaces of both, the B&R X20 CPU and the DUT to the hub.

Create an Automation Studio project, select the available B&R X20 CPU and then import the DUT's XDD file using "Tools – Manage 3<sup>rd</sup> party devices – Import Fieldbus Device".

An openSAFETY device typically has two device description files (\*.XDD, \*.XOSDD). During device import, select the \*.XOSDD file before the \*.XDD file.

For a modular device, import the head \*.XDD (bus coupler) and the related child \*.XDD (modules) files.

Insert the imported DUT by searching the DUT in the "Hardware Catalog" and dragging it into the "System Designer" or the "Physical View" under the POWERLINK interface or by selecting the POWERLINK interface and double-clicking the DUT in the "Hardware Catalog".

For testing an openSAFETY device, also insert an X20SL8100 SafeLOGIC and set "module supervised" in I/O Configuration to "off".

Set up a mimimum SafeDESIGNER project, where the SafeModuleOK channels of all openSAFETY devices are used. This allows easier verification and to check correct (safety packet) routing functionality inside the device.

The "Safe Data Duration" has to be set accordingly. For example, setting a "Safe Data Duration" of 200 milliseconds, respectively 200000  $\mu$ s, should be big enough for all related test cases below.

Download the project to the PLC. Download the safety project to the SL and acknowledge device and firmware changes.

## 3.3 Test execution

The execution of some tests is depending on the DUT's device type. Where applicable, specifcally marked paragraphs cover information on differing or additional required procedures. A related summary can also be found in Tab. 3, p. 28.

#### 3.3.1 PDO test

#### 3.3.1.1 General

This test verifies the mapping of objects to the PDO frames PollRequest and PollResponse. Both directions are tested.

openSAFETY over POWERLINK devices have dedicated channels (TPDO and RPDO) for openSAFETY communication, which are enabled by default in Automation Studio and cannot be deactivated. Safe output channels are not visible in Automation Studio.

In case the head station of a modular device does not have mappable objects by itself, related child modules shall be attached (physically and in the AS project) in order to activate input/output channels.

#### 3.3.1.2 PDO1

Map an input object (TPDO-mappable object of the DUT) by enabling a "read" channel in the I/O Configuration page (Parameter group "Channels") of the DUT. The selected object should be manually changeable on the DUT (e.g. ActualPositionValue on an encoder).

The object must be named by the applicant engineer.

For a modular device, attach an input module or map an input object by enabling a "read" channel.

Download the project to the PLC and verify a changing signal in monitor mode of AS.

If no input object is available, this test is not applicable.

If the device only offers openSAFETY-related channels, the device has to be booted up successfully by the SL to observe safe signal changes in AS. An according signal should be manually changeable on the DUT (e.g. SafeActualPositionValue on an encoder).

The object must be named by the applicant engineer.

Download the project to the PLC and verify a changing signal in monitor mode of AS.

If the device does not have safe channels in input direction, verify with the SafeDESIGNER that the SafeLOGIC is in "Run" and SafeModuleOK of the DUT is set (true).

#### 3.3.1.3 PDO2

Map an output object (RPDO-mappable object of the DUT) by enabling a "write" channel in the "I/O Configuration page" (Parameter group "Channels") of the DUT. The selected object should trigger a visible action on the DUT (e.g. DigitalOutput indicated by a LED).

The object must be named by the applicant engineer.

For a modular device, attach an output module or map an ouput object by enabling a "write" channel. Download the project to the PLC and verify a changing signal on the DUT in monitor mode (force) of AS.

If no output object is available, this test is not applicable.

If the device only offers openSAFETY-related channels, the device has to be booted up by the SL. An according safe signal should trigger a visible action on the DUT (e.g. SafeDigitalOutput indicated by a LED).

The object must be named by the applicant engineer.

Verify a changing signal on the DUT in SL debug mode with activated variable status (overwrite) with SD.

If the device does not have safe channels in output direction, verify with the SafeDESIGNER that the SafeLOGIC is in "Run" and SafeModuleOK of the DUT is set (true).

## 3.3.2 Multiplex test

#### 3.3.2.1 General

This test verifies the feature "Multiplexing" on the DUT. It is only applicable if the DUT's XDD file declares the feature DLLCNFeatureMultiplex="true".

#### 3.3.2.2 MUX1

Enable Multiplexing in the DUT's I/O Configuration page and download the project to the PLC. Verify in the network trace that the DUT is behaving correctly (responding to the PReq that is only sent every  $n^{\text{th}}$  cycle). The value *n* is given by the parameter "Multiplexing prescale" in the POWERLINK Configuration of the PLC.

Use two different numbers for *n* to approve this test, e.g. 3 and 5.

Also force the multiplexed cycle on the DUT's I/O Configuration page to the first, middle and last multiplexed cycle.

#### 3.3.3 Cycle time test

#### 3.3.3.1 General

This test verifies the reduced, minimum and maximum cycle time of the DUT.

When testing an openSAFETY device, disconnect the SafeLOGIC from the hub for this test.

#### 3.3.3.2 CycleTime1

No configuration in AS is necessary for the reduced cycle time test. The value is automatically imported from the XDD file.

Download the project and restart the PLC. Check that the DUT boots up to CS\_PRE\_OPERATIONAL\_2 or higher, e.g. by a Wireshark trace.

#### 3.3.3.3 CycleTime2

Configure the minimum cycle time possible by the DUT (feature "NMTCycleTimeMin" in the XDD) and the MN in the MN POWERLINK interface configuration. Verify that the DUT boots up to CS\_OPERATIONAL and stays operational for at least 1000 cycles, e.g. by a Wireshark trace.

### 3.3.3.4 CycleTime3

Configure the maximum cycle time possible by the DUT (feature "NMTCycleTimeMax" in the XDD) and the MN in the MN's POWERLINK interface configuration. Verify that the DUT boots up to CS\_OPERATIONAL and stays operational for at least 1000 cycles, e.g. by a Wireshark trace.

## 3.3.4 Data load test

#### 3.3.4.1 General

This test verifies the minimum and maximum possible load of synchronous data mapped to a PDO frame. If a DUT only supports static mapping, DataLoad1 and DataLoad2 are not applicable.

openSAFETY over POWERLINK devices have dedicated channels (TPDO and RPDO) for openSAFETY communication which are enabled by default in Automation Studio and cannot be deactivated. Safe output channels are not visible in Automation Studio.

The SafeLOGIC has to be connected for this test.

### 3.3.4.2 DataLoad1

Set all channels in the "I/O Configuration Page" (Parameter group "Channels") of the DUT to "none".

For a modular device, remove all attached modules from the head station and deactivate all channels.

Verify that the DUT boots up to CS\_OPERATIONAL and stays operational for at least 1000 cycles, e.g. by a Wireshark trace.

This test is not applicable for an openSAFETY device.

### 3.3.4.3 DataLoad2

Activate one channel (in each direction) in the "I/O Configuration Page" (Parameter group "Channels") of the DUT. The channel with the smallest data size should be selected.

For a modular device, attach an input and an output module or activate one channel in each direction.

The safety channels of an openSAFETY device are enabled by default, therefore no channels have to be activated manually.

Verify that the DUT boots up to CS\_OPERATIONAL and stays operational for at least 1000 cycles, e.g. by a Wireshark trace.

## 3.3.4.4 DataLoad3

Activate the maximum number of channels (in each direction) in the "I/O Configuration Page" (Parameter group "Channels") of the DUT. Channels with larger data sizes should be used.

For a modular device, attach several input and output modules and/or activate the maximum number of channels in each direction.

For an openSAFETY device, activate further channels additionally to those already enabled by default.

Verify that the DUT boots up to CS\_OPERATIONAL and stays operational for at least 1000 cycles.

#### 3.3.5 Cross traffic test

#### 3.3.5.1 General

This test verifies the ability of the DUT to read PollResponse frames of one or several other CNs in the network.

Read out the value of the feature "PDORPDOChannels" in the DUT's XDD file. If this value is 1, none of the cross-traffic tests are applicable. If this value is 2, CrossTraffic1 and CrossTraffic2 are applicable. For any higher value, also CrossTraffic3 is applicable.

For a modular device, attach as many output modules to the head station, as needed to have three different objects mapped. Configure cross-traffic on these modules, so that those objects will be used.

For an openSAFETY over POWERLNK device, one RPDO object is mapped by default to the PRes of the SafeLOGIC and is used for openSAFETY communication. In general, a working cross-traffic functionality can be assumed, if PDO tests have been successful.

When the device does not have non-safe output channels, or the value of "PDORPDOChannels" is below 3, none of the cross-traffic tests are applicable.

If this value is 3, CrossTraffic1 and CrossTraffic2 are applicable. For any higher value, also CrossTraffic3 is applicable. The SafeLOGIC is required to be connected for this tests.

### 3.3.5.2 CrossTraffic1 (PReq + PResMN)

The test is carried out via an iCN configuration. Cf. also the Automation Studio help:

- 1. Create a configuration for the MN in the AS project.
- Add the DUT to the MN configuration and choose two objects (RPDO-mappable objects): one will be used for direct communication (i.e. PReq from MN) and one will be used for the crosstraffic test (i.e. PRes from MN). These objects should trigger visible actions on the DUT (e.g. DigitalOutput indicated by a LED). They must be named by the applicant engineer.
- 3. Activate the mapping of the two objects by setting the according channels to "Write" in the I/O Configuration page of the DUT.
- 4. Open the POWERLINK Configuration of the MN and create one broadcast channel with the same data type as the DUT's object for cross-traffic:

#### 3.3.5.3 CrossTraffic2 (PReq + PRes iCN)

- Add the DUT to the MN configuration and choose two objects (RPDO-mappable objects): one will be used for direct communication (i.e. PReq from MN) and one will be used for the crosstraffic test (i.e. PRes from iCN). These objects should trigger visible actions on the DUT (e.g. DigitalOutput indicated by a LED). They must be named by the applicant engineer.
- 3. Activate the mapping of the two objects by setting the according channels to "Write" in the I/O Configuration of the DUT.

  - 15. For the cross-traffic-mapped object (PRes from iCN), set the iCN Configuration active, go online on the iCN CPU and activate the monitor mode.
  - 16. Open the POWERLINK I/O Mapping page of the iCN, force a value on the output channel and verify the reaction on the DUT.

### 3.3.5.4 CrossTraffic3 (PReq + PResMN + PRes iCN)

The CrossTraffic3 test combines both, CrossTraffic1 and CrossTraffic2 at the same time. Therefore, three RPDO-mappable objects must be available and named by the applicant engineer:

- One object is mapped to the PReq of the MN
- One object is mapped to the PRes of the MN
- One object is mapped to the PRes of the iCN

Carry out the test by verifying a reaction on the DUT after forcing all three objects.

#### 3.3.6 Advanced extension compatibility test

#### 3.3.6.1 General

The extension compatibility tests shall ensure that the DUT is able to cope with existing and possible future extensions of the POWERLINK protocol.

## 3.3.6.2 ExtensionCompatibility1 (PRes Chaining test)

Verify that the DUT boots up to CS\_OPERATIONAL and stays operational for at least 1000 cycles, e.g. by a Wireshark trace.

## 3.3.6.3 ExtensionCompatibility2 (Multi ASnd test)

This test shall verify that a device not supporting Multi-ASnd ignores unknown POWERLINK message types (e.g. the Alnv frame), and that it can cope with more than one ASnd frame in the asynchronous phase at low cycletimes.

The test setup contains a B&R X20 POWERLINK MN, a B&R X20 POWERLINK iCN and the DUT. Both, the MN and the iCN are permanently sending ASnd frames to the DUT, causing AInv frames and up to two ASnd frames in the asynchronous phase on the network.

The pre-configured attached AS project to run this test executes the tasks for sending the ASnd frames on both, MN and iCN.

This section outlines the procedure for conducting the MultiASnd test using the predefined B&R project. The process involves the following steps:

#### Setup:

Connect the Managing Node (MN) the Controlled Node (iCN) and the device under test to a standard ethernet hub. Use the built-in POWERLINK ports for connection, no special hardware is required. Also connect the MN to a PC via an Ethernet port.



#### **Configuration:**

- 1. Open the project file.
- 2. Adjust CPU settings in Configurations 1 and 2 to align with the specifications of your setup, ensuring compatibility with your specific CPU type.
- 3. Set up online settings on the MN's Ethernet interface (Configuration 1).

- 4. Import and assign Node Number 1 to the device under test, and Node Number 2 to the iCN.
- 5. Download Configuration 1 to the MN and Configuration 2 to the iCN.

#### Execution:

- 1. Start Wireshark and connect to the POWERLINK network.
- 2. Select MN configuration and establish an online connection to the MN
- 3. Activate monitor mode (Strg + M).
- 4. Open iCN's I/O Mapping (Physical view -> rightclick on epl\_icn -> I/O mapping) and activate the 'floodAsnd\_enable' channel.
- 5. In the Logical View, right click on the program 'FloodASnd' and open its watch.
- 6. Add variables and set 'enable' to true.

#### Verification:

Monitor the results in Wireshark. Verify that at least two asynchronous slots are being used in each cycle throughout the test. Also check that the DUT boots up to CS\_OPERATIONAL and stays operational for at least 1000 cycles

#### 3.3.7 Timeout test

#### 3.3.7.1 General

These tests shall ensure that the DUT is able to operate within the timing parameters given in its XDD file.

#### 3.3.7.2 Timeout1

The DUT shall respond to a PReq within the PRes response time (object 0x1F98/3) given in the XDD file. Read out the value of this object, divide it by 1000 (convert ns to µs) and set it in the I/O Configuration page of the DUT. Configure the MN with the minimum possible cycle time (feature "NMTCycleTimeMin").

Verify that the DUT boots up to CS\_OPERATIONAL and stays operational for at least 1000 cycles, e.g. by a Wireshark trace.

#### 3.3.7.3 Timeout2

The DUT shall respond to an SoA within the SoA response time (object 0x1F98/6) given in the XDD file. Read out the value of this object, divide it by 1000 (convert ns to  $\mu$ s) and set it in the POWERLINK I/O Configuration page of the MN. For values less than 5 $\mu$ s, the setting must be 5 $\mu$ s. Configure the MN with the minimum possible cycle time (feature "NMTCycleTimeMin").

Verify that the DUT boots up to CS\_OPERATIONAL and stays operational for at least 1000 cycles, e.g. by a Wireshark trace.

#### 3.3.7.4 Timeout3

In this test the DUT shall respond to a PReq after the time "SoC to first PReq" has elapsed. This value is given in the XDD file via the feature "NMTCNSoC2PReq" and is automatically used by Automation Studio.

Use the DUT as the only device besides the MN in the network. Verify that the DUT boots up to CS\_OPERATIONAL and stays operational for at least 1000 cycles, e.g. by a Wireshark trace.

Configure the MN with the minimum possible cycle time (feature "NMTCycleTimeMin").
